**2026 Academic Year  
Subsidies for Compulsory Education  
Elementary and Junior High School Attendance**

Matsue City provides subsidies for all or part of the expenses --- such as school lunches and school supplies --- to guardians of elementary school and junior high school students who find it difficult to pay those expenses.

Guardians who wish to receive these subsidies, hereinafter referred to as “subsidies”, should read the following items carefully and complete the necessary procedures. Guardians already receiving public welfare do not need to fill out an application.

**1. Households eligible for the subsidy**

- ① Guardians of children attending or who will attend any of Matsue City’s municipal schools
- ② Guardians of children attending a national or private school within Matsue City, or a school outside of Matsue (excluding national and private schools) that have a registered address in Matsue City.

Households that fulfill the requirements outlined in either ① or ② above and fulfill one of the following criteria are eligible for the aforementioned subsidies.

1. One’s welfare has ended or been suspended	No documents necessary
2. One has been exempted from paying Municipal Tax	No documents necessary (People who moved in on or after January 2, 2025 must submit a copy of their tax declaration certificate from their previous residence)
3. One is paying a reduced amount for their Municipal Tax	Notice of Change in Prefectural/Municipal Tax (Copy)
4. One is paying a reduced amount for their Individual Enterprise Tax	Notice of Payment Reduction (Copy)
5. One is paying a reduced amount for their Property Tax	Notice of Decision on Payment Reduction (Copy)
6. The contributions one pays to the Japanese National Pension System have been reduced by 1/2 or more	National Pension Contribution Deferment/ Approval Notice for Contribution Deferment (Copy)
7a. The amount one makes in payments to National Health Insurance has been reduced.	Approval Notice for Deferment on Contributions to the National Health Insurance System (Copy)
7b. One has been granted a grace period for making payments to the National Health Insurance System	Notice of Decision on Grace Period for Collecting Contributions (Copy)

\*The figures listed here are rough estimates. Approval for subsidies will depend on the results of a financial screening.

Earned Income - the amount one's left with after essential expenses have been deducted from one's salary

Annual Income - the amount present before withholding tax is deducted from one's wages and bonuses

\*If you are not sure whether you are eligible for the subsidy, we highly recommend you apply first.

(2) Despite having had sufficient income in the previous fiscal year, one now has a much smaller income because of a job suspension, a job change or a job resignation, etc.

Documentation that proves one's current circumstances  
(Copy of Unemployment Insurance Beneficiary Certificate, Proof of Unemployment, etc.)

(3) One is in a financially difficult situation because of debt repayment due to joint liability or medical expenses.

Copies of documents that prove one's present situation (documents that prove amount of debt repayments, medical expenses, etc.).

(If more than one item is applicable, please attach the necessary documents for only one of the items.)

※ **You must reapply every year even if you are already receiving the subsidy.**

**Please note:**

- Home and car loan repayments will not be considered in your application.
- Even if your registered residence is different from your family's (because of a job transfer, etc.), or if there are multiple heads of household living in the same home together, people living in the same house together will be regarded as one household and have their income calculated together.
- Generally, people living on the same property but in different buildings will be regarded as one household and have their income calculated together. Therefore, if your incomes are not shared, you will need to submit a copy of your respective electricity bills, gas bills, water bills, building leases, or other documents that prove you are separate households.
- There are instances in which a financial screening will be conducted based on your most recent income. For those whose household income has decreased due to a household member becoming unemployed, or due to some other special circumstance, please schedule a consultation with the Matsue City Board of Education.

## 2. How to Apply

### Documents to submit:

**(1) "Application Form for Authorization of Financial Assistance for Schoolchildren (and Enrollment Preparation Funds / Household Member List / Letter of Attorney/ Letter of Consent/ Account Transfer Application)"**

※ The application form is available **starting in December** at schools and the Board of Education.

**(2) Copy of Bank Passbook**

**(3) A document proving circumstances that necessitate a subsidy**

(please consult the above table... [**1. Households eligible for the subsidy**])

**Please submit the documents to the school your child is currently enrolled in or will attend in the future.**

- ※ If your child has siblings enrolled in a Matsue City municipal elementary or junior high school, please fill in **only one** application for both students and submit that form to the elementary school.
- ※ If you have children enrolled in a national or private schools (Shimane University Education Department Office, Kaisei Middle School, Shotoku Gakuin Middle School, etc.), please submit a separate form to each school.
- ※ Households that will move out of Matsue City by **March 31<sup>st</sup>, 2026** cannot apply.
- ※ Households that may move out of Matsue City by **March 31<sup>st</sup>, 2026** due to circumstances such as a job transfer, please consult with the board of education before applying.

## 3. Application Submission Period (Application certification will be at the beginning of the 2026 academic year)

The application submission period is from December to the beginning of January. Please check with your child's school for a specific deadline.

※The submission date differs with each school, so please check with your child's respective school.

**\*For households who plan on enrolling their child in their 7<sup>th</sup> year of compulsory education, or their 1<sup>st</sup> year of elementary or junior high school for April of 2026...**

Funds for enrollment preparation or funds for entering the next level of education will be provided in order to cover expenses for things such as new school supplies.

Although the purpose and the payment amount for both funds are the same, the disbursement period is different. Also, you will only be supplied with one of them.

■ If you submit the application by the deadline designated by the school

→ **You will receive the support funds for enrollment preparation at the end of March**

■ If you have missed the original deadline, and submit your application by the end of April

→ **You will receive the support funds for entering the next level of education at the end of May**

Applications submitted during the middle of the academic year are accepted by each school. In the event that your application is accepted, it will be considered so beginning the month you submitted the application. Those thinking of applying for this aid, please submit your application as early as possible.

※For schools that fall under the compulsory education institutional system, grades 7, 8, and 9 are referred to as junior high school grade 1, 2 and 3, respectively.

Students who will enter grade 1 of junior high school are treated as students planning on attending junior high school.

**Note 1:** The subsidies for the “enrollment preparation funds” and the “cost of school supplies for newly enrolled students” will not be paid out if the recipient already received them from another municipality.

**Note 2:** Not applicable to children from outside the school district, area, and to those who attend national or private schools.

**Note 3:** For families with children attending national or private schools, or schools outside their school district, the maximum amount is capped at the average amount paid to students attending municipal schools from the previous fiscal year.

**Note 4:** Applicable only to children who attend municipal schools.

※ Depending on the status of your application, your certification classification and your child's enrolment circumstances, there may be limits on how many times you will receive the subsidy, as well as limit on the subsidy amount paid out.

**Please check what the necessary process is for obtaining the aforementioned subsidies.**

- Subsidies are paid out based on reports submitted by schools to the Board of Education, so parents and guardians do not need to submit any paperwork directly to the Board of Education.

- The subsidies will be deposited directly by the Board of Education into an account of a financial institution designated by the child's guardian. If a parent or guardian has delegated the school's principal to receive the subsidy on their behalf,

the subsidies will be transferred to the school's account.

## 5. Notice of Approval (Certification at beginning of the academic year)

The submitted application will be reviewed by the Board of Education. The notice of approval (or rejection) will be mailed as a document to the child's guardian by the Board of Education. The notification period will vary depending on the day the application was submitted, and whether the child is a new enrollee or not.

\*\*\*Keeping in mind that new applications will be accepted at any time, you will be notified of your application's results once a review has been conducted.

### Notification Period:

- 1 Households with newly enrolled children (including those in their 1<sup>st</sup> year of junior high school) that submitted their application by the deadline designated by the school ...
  - the beginning of March (approval or rejection)
- 2 Households other than those specified in case (1)
  - the end of April (rejection)
  - the middle of May (approval)

### Please note:

- If there is a change to your household structure after applying (such as marriage, divorce, or a change in residence of a household member), your household circumstances will need to be re-evaluated. If such changes occur, please notify the school your child attends promptly.

## 6. Notice

Enrollment subsidies are paid out to households to subsidize costs related to the child's enrollment in school. If the money you received is used for something unrelated to enrollment costs, or if there was any false information in your application, the provision of these subsidies may be canceled. Please apply once you have acknowledged and agreed to these terms.

**If you do not pay the enrollment costs despite receiving enrollment subsidies, the money will instead be paid directly to the school itself. Also, if you are requested to return a portion of the subsidy, please do so immediately. If you default on this payment, you will be no longer eligible for receiving the enrollment subsidies.**
